2. Release and Waiver of Liability

I, on behalf of myself, the Participant, and our heirs, assigns, and representatives, hereby release, waive, discharge, and hold harmless Dana Point Breakers, its owners, directors, coaches, trainers, volunteers, agents, independent contractors, and affiliates from any and all claims, demands, actions, or causes of action arising out of or related to participation in any Club activities, including negligence, to the fullest extent permitted by law.

3. Medical Authorization

In the event of illness or injury, I authorize Dana Point Breakers and its representatives to obtain medical treatment deemed necessary for the Participant. I accept full financial responsibility for any medical expenses incurred.

4. Code of Conduct & Safety

I acknowledge that the Participant is expected to follow all Club rules, coach instructions, and safety guidelines. Failure to do so may result in disciplinary action or removal from activities, without refund.

5. Photography & Media Release

I grant permission for Dana Point Breakers to use photographs or videos of the Participant taken during practices, games, or tournaments for marketing, promotional, or educational purposes, without compensation.

6. Governing Law

This Agreement shall be governed by and interpreted under the laws of the State of California.

Monthly Tuition

- \$350 per month due on the 1st of the month
- 4-month minimum commitment required
- \$100 one-time fee for uniform (practice jersey, game uniform, long sleeve shooting shirt)

What's Included

- **Practice Requirements and Times:**
 - 14 hours per month
 - 3.5 hours per week
 - Monday 7:30 - 8:30 pm
 - Thursday 6:00 - 7:30 pm
 - Friday 6:00 - 7:00 pm
- **Tournaments:**
 - Two (2) tournaments per month on **every other Saturday**
 - Two (2) games per tournament appearance

Additional Notes

- Fees cover coaching, practice facility time, and program administration.
- Tournament entry fees are included unless otherwise communicated.
- Travel, lodging, and personal expenses are not included unless specified.
- Dana Point Breakers t-shirt and hat provided at sign up for no additional charge.

Payment Policy

- Tuition is due on the 1st of the month, payable to Shawn Bodnar via Venmo (@Shawn-Bodnar-1) or Zelle (714-292-4494).
- Missed practices, games, or tournaments do not result in refunds or credits.
- Early withdrawal does not automatically waive the 4-month financial commitment.
